**BUSINESS/PREMIUM BOOTH - GENERAL GUIDELINES**

- I understand that all information, updates, etc. regarding the 2020 GOSF will be sent via the email address listed on the application
- All applications are subject to review by the GOSF Committee
- You will receive an accepted/declined notice via email after your application has been reviewed by the GOSF committee
- No booth sharing is permitted
- A 15X15 Business Booth site receives 3 vendor passes and 1 parking pass
- A 15X30 Business and 20X20 Premium Booth site receives 6 vendor passes and 2 parking passes
- A limited number of additional vendor passes may be purchased in advance of the festival
- NO additional parking passes will be available
- Limited power (via generators) is available (Please note in the special instructions portion of the application if your booth requires power)
- No raffles will be permitted. An '*Opportunity to Win*' may be offered during the festival and all drawings shall take place after the Festival closes on Sunday at 5:00 p.m.
  - **Note:** The Great Ogeechee Seafood Festival, Richmond Hill/Bryan County Chamber of Commerce, their employees, volunteers or committee members are not responsible for any *Opportunity to Win* or prize distribution
- No "hawking" or shouting from booth or pathway and no harassing festival goers
